MANAGEMENT REPORT:

GMU continues to help Fontanelle and Orient as needed. Lake levels were reviewed. Stack testing on two units at the North Generation Plant is upcoming. The water main project on NE Hayes St is completed with the exception of dirt work to be done this fall and the crew has moved to NE Grant for the next phase of the project. Almost all parts and equipment for the radiator repair at the North Generation Plant have arrived and the repair will be begin soon. There are a couple commercial electrical upgrades to complete after the water line on NE Grant is complete before the crew moves onto the next phase of overhead to underground electric conversion.
