This resolution moves the meter reading date to the last business day of the month and the payment due date from the 20<sup>th</sup> of each month to the 25<sup>th</sup>. ## **MANAGEMENT REPORT:**

The GMU crew continues to help Fontanelle and Orient as needed. Tonderum reported on the final items on the Downtown Generation Plant punch list that are to be completed by June 30, 2021. The water main project on NW 2<sup>nd</sup> St is substantially complete with the exception of the final dirt work and clean up. The next project will be overhead to underground electric conversion in the NW section on town. The lake levels were reviewed and will continue to be monitored closely.
